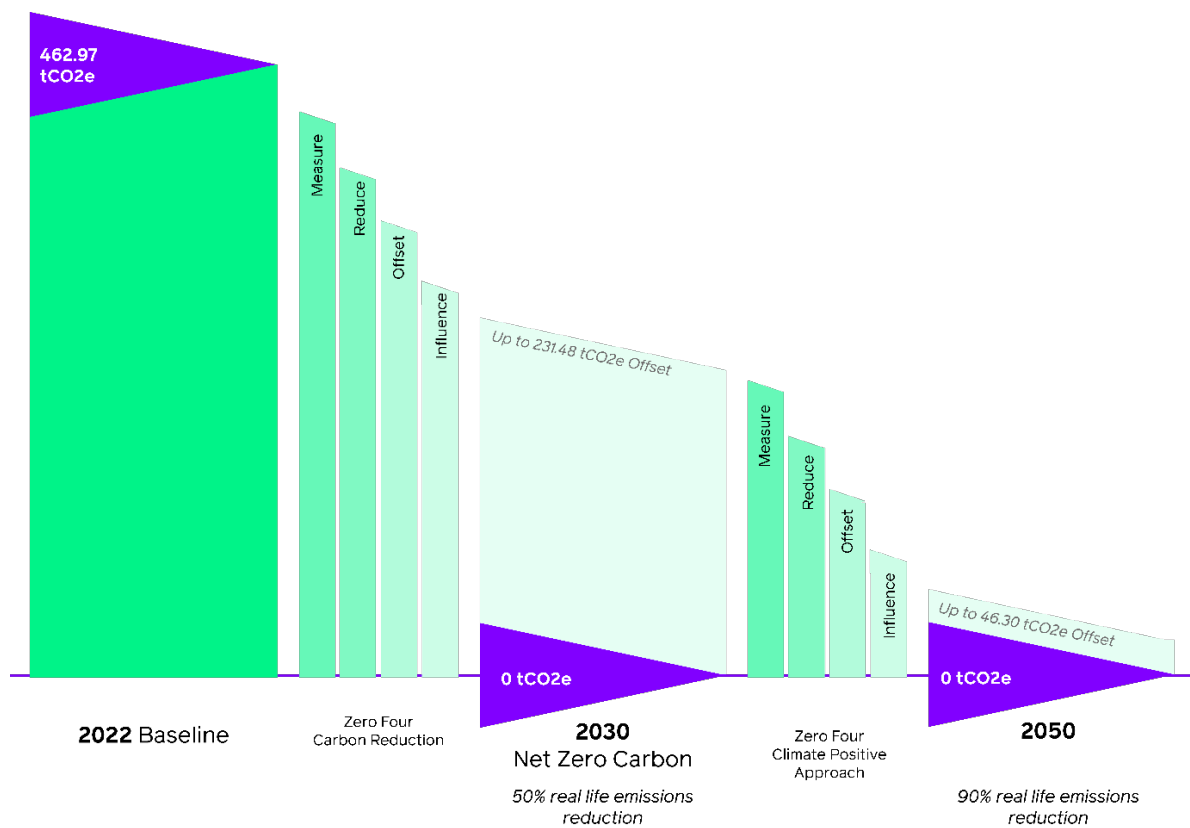

## Emissions Reduction Targets

**2030 net zero:** reduce our carbon emissions by at least 231.48tCO<sub>2</sub>e, 50%, and use carbon offsetting to eliminate any residual carbon.

**2050 net zero maintained:** reduce our carbon emissions by at least 416.67tCO<sub>2</sub>e, 90%; any remaining carbon offset.



## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

Although our formal baseline year is 2022, we have been on the path towards net zero carbon since 2019. In this time, we have managed to reduce our emissions against both Scope 2 and Scope 3, through:

- Partnering with green energy suppliers in our offices – all energy now from sustainable sources
- Work From Home initiative, encouraging our staff to work from home approximately 2 days per week – reducing our travel and also consumption of energy and other resources within the office
- Business Travel improvement: we are part of the Cycle to Work Scheme, cover the cost of Santander Bicycle Subscriptions for all employees, and have partnered with Octopus for electric vehicles, making them more affordable for staff via a Salary Sacrifice process. This has improved the carbon footprint on some parts of our employee commutes, as well as benefitting our staff's personal footprints.

In the future we hope to implement further measures such as:

- Installing heat pumps in our London office
- Introducing new energy saving measures in our offices, as yet to be finalised
- Purchasing all our paper products from recycled sources
- Implementing local plant based catering – encouraging the majority of our food to be plant based and purchased locally. This has already reduced our meat consumption, and is an ongoing initiative.
- Carbon Offsetting from 2030 onwards. Offset projects are to be decided based on our direct supply chain.

## Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.
